U.S. Geological Survey Western Ecological Research Center, repair existing barn, tack house, and cabin, stable building, covered equestrian arena, greenhouse, gardens and agricultural outbuildings, portable toilets, demolish existing uninhabitable house, Nature/Conference/Activity Center, 18 tent cabins, three restroom/shower buildings, terrace area with picnic tables, staff/caretaker residence, fire rings, ropes course, improve St. Johns Mine Road (trim vegetation, grade embankment, striping), two septic tanks with disposal fields, improve existing well water supply or connect to City water supply, fire hydrants, improve existing driveway for emergency vehicle access, remove non-native trees, landscape renovation, internal access roads, approximately 100 parking spaces in three locations on site, and carpool parking at St. Johns Mine Road/Columbus Parkway.
